Use of Sports Premium 2021 - 2022

The initial allocation of Sports Premium for 2021 – 2022 is approximately £18650.

The Sports Premium will be used to:

- Continue to strengthen involvement of Broxtowe Active Schools and Premier Sport in supporting the provision of high-quality provision.
- Provide a programme of afterschool clubs.
- Re-engage with competitive sport opportunities as part of recovery from Covid-19 interruptions.
- Provide transport to sporting events for large groups.
- Support the PE coordinator in his leadership role and involvement in sport development within the school, across the district and as a head teacher ambassador for the Youth Sport Trust.
- Provide CPD opportunities in PE for teachers and trainee teachers as required.
- Support the school's participation in activities organised by the School Sports Coordinator for Broxtowe District.
- Provide additional staffing support for attendance at sporting events and PE and Sport related extra-curricular activities.
- Support the school's participation in activities organised by Eastwood and District Primary Schools Sports Association.
- Support the re-introduction of off-site outdoor and adventurous related day visits and residential visits.
- Provide opportunities for Y5/6 children to become Sports Leaders who lead break and lunchtime activities.
- Support lunchtime activity provision with a sports coach two days a week.
- Promote inclusive PE and sporting opportunities across the school.
- Continue to enhance the school's active curriculum agenda through license purchase of Teach Active.
- Enhance the school's curriculum provision through its use of Complete PE.
- Engage the services of Sports coaches to enhance the quality of our provision for Physical Education and extra-curricular sports activities and clubs
- Purchase additional sports equipment and storage.
- Support the use of the planned multi-use games area through the purchase of related teaching / learning material
